The following summary information has been prepared for the Board regarding the mid-year status of the 2024-2025 Adopted Budget. Staff has reviewed revenues and expenditures through December 31, 2024, and projected balances through fiscal year-end based on current activity.

#### Operating Revenues

Based on the District's first property tax apportionment in December, net property tax revenues are estimated to exceed budget estimates by \$23,189.

Other revenues and transfers are also estimated to be above budget estimates, mainly the result of additional out-of-county deployment reimbursements over the \$72,800 included in the adopted budget. Resolution 25-02, included as Recommendation No. 2, is presented for review and approval to increase revenues and expenditures by an additional \$463,100 for actual reimbursements of personnel expenditures and apparatus usage from this activity. The estimates provided in this report incorporate this resolution.

These items are estimated to result in approximately \$70,772 additional operating revenue above budget projections through fiscal year-end.

### Operating Expenditures

Total Operating Expenditures are estimated to be under budget by \$63,422. This total is comprised of Wages and Benefits, which are estimated to be under budget by \$46,831, and Services and Supplies, which are estimated to be under budget by \$16,591.

### Operating Net Revenue

Based on current revenue and expenditure estimates outlined above, net operating revenues are projected to exceed budgeted expenditures by \$168,094 after the annual \$400,000 contribution to the capital fund.

Staff will update revenue and expenditure estimates monthly and report back to the Board before fiscal year-end with recommendations for any additional revenue or expenditure amendments to the operating budget.

### **Recommended Actions:**

1. Board review and receive report;
2. Approve Resolution No. 25-02 adopting the first amendment to the 2024-2025 Operating Budget in the amount of \$463,100.

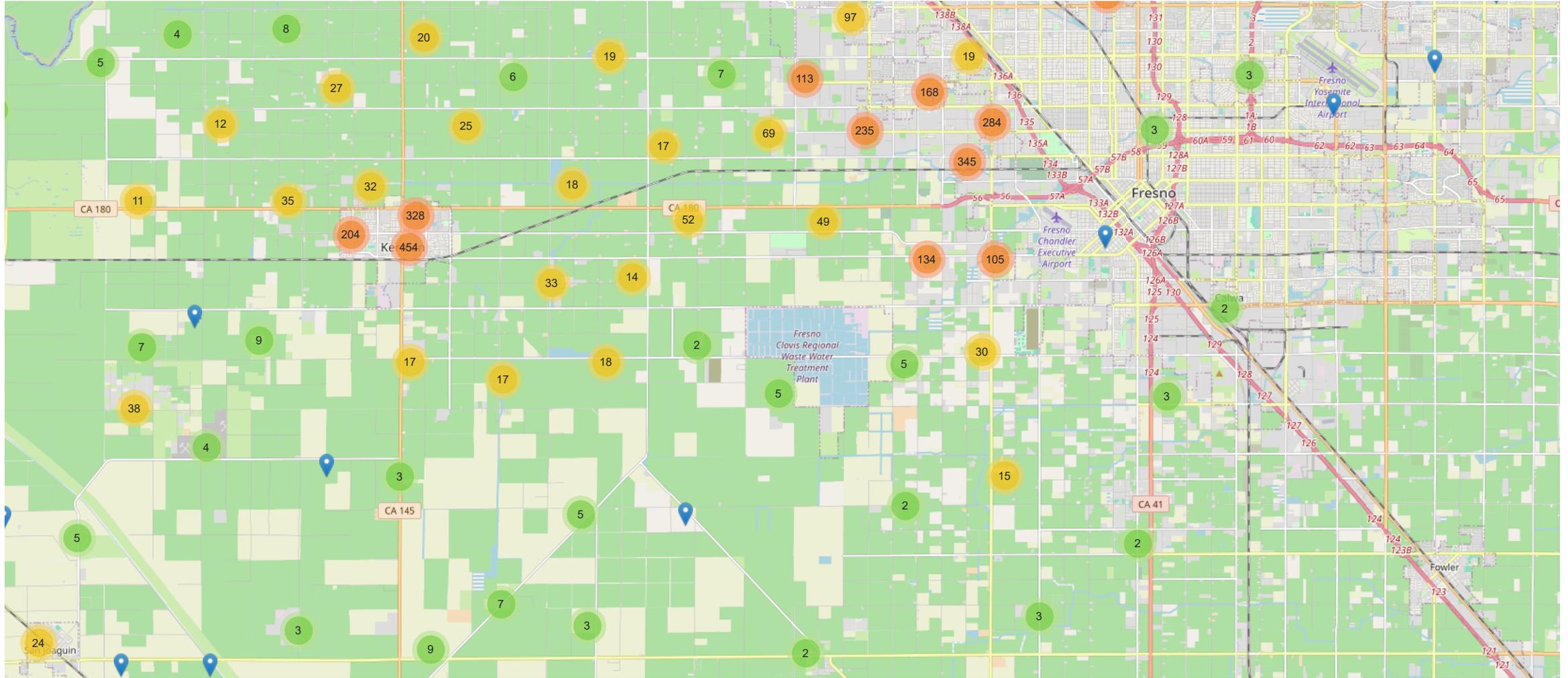

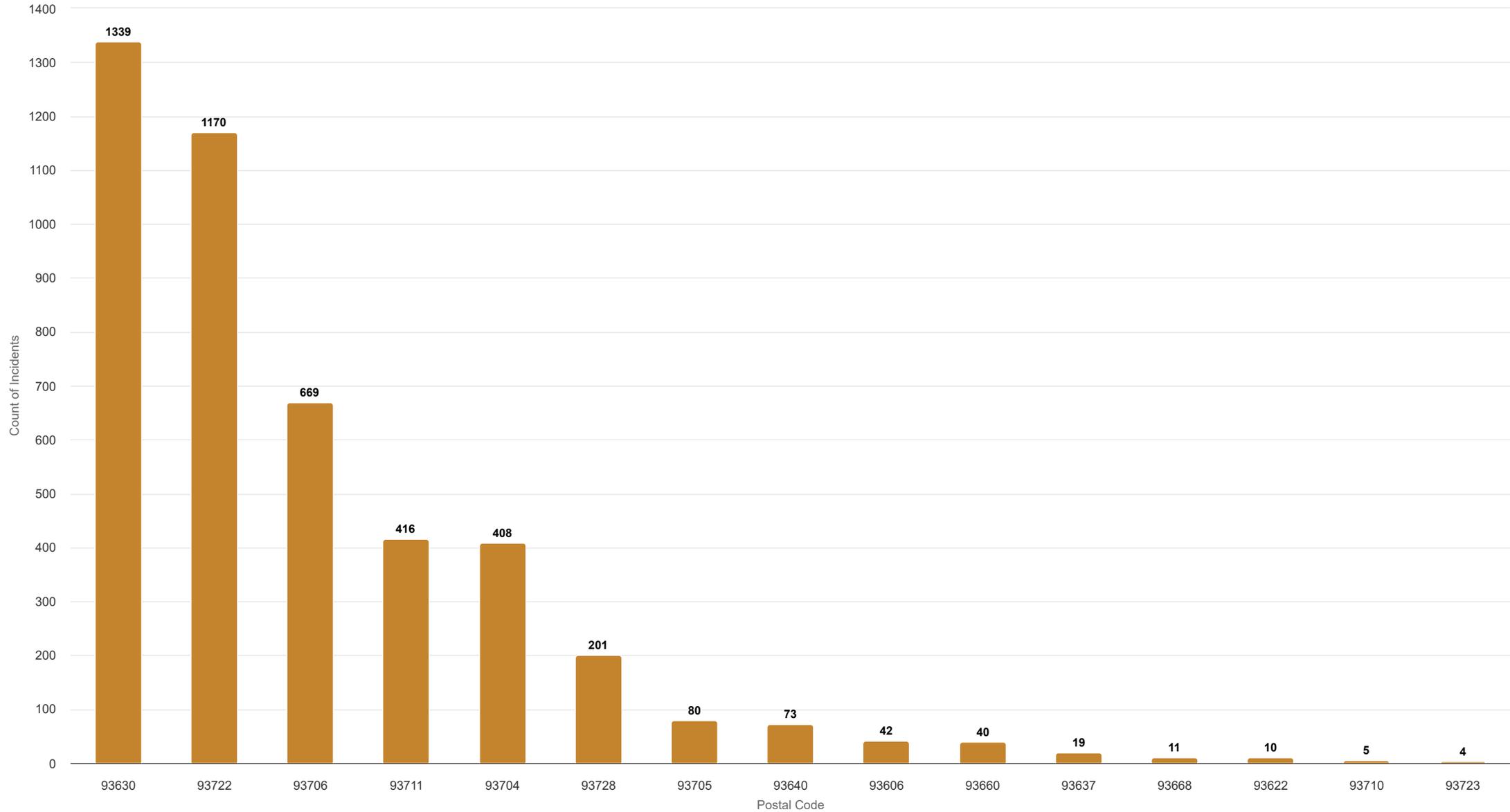
Scene Locations of Fire Incidents

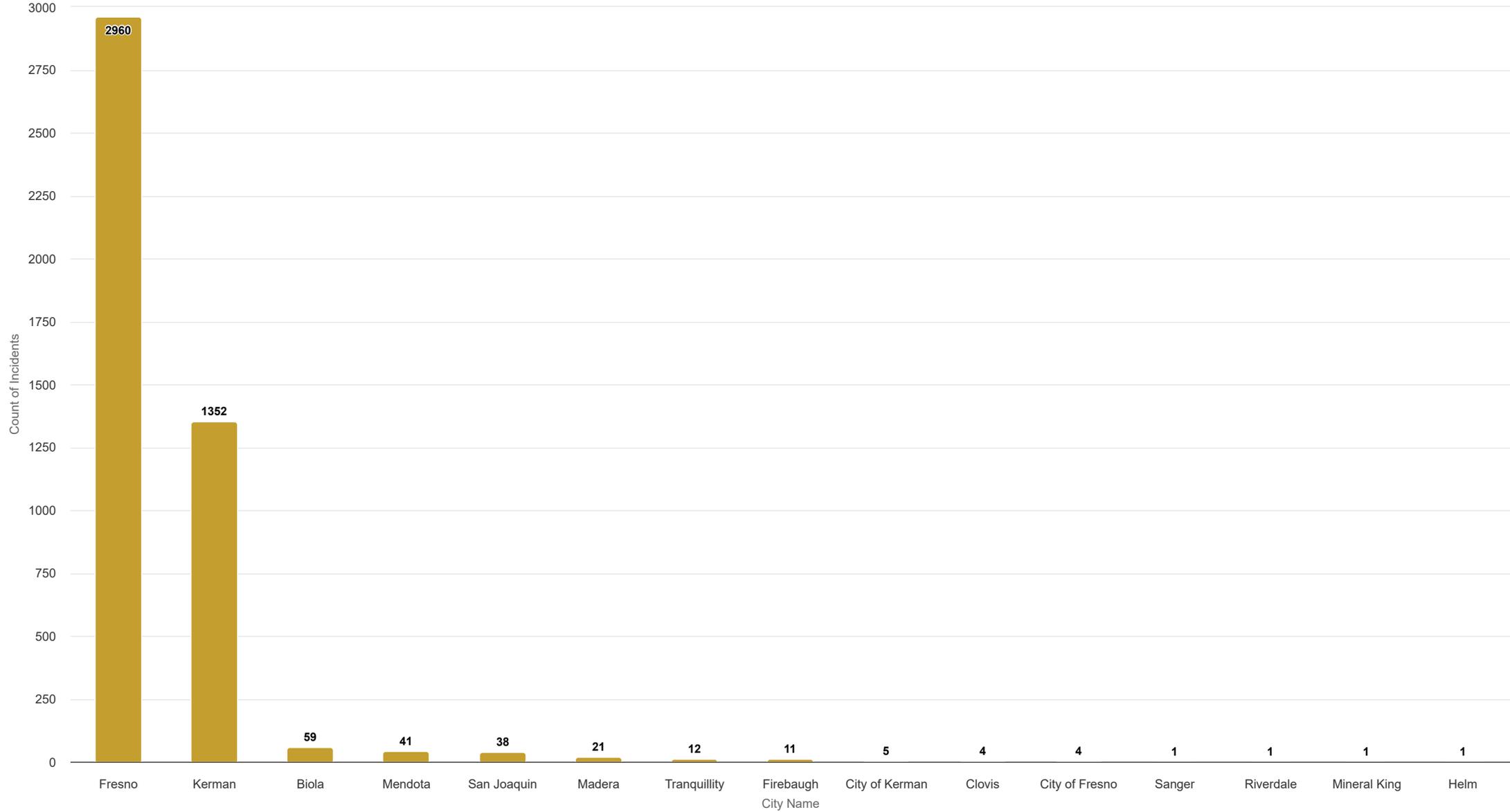
**Incidents by Postal Code**

Jan 01, 2024 to Dec 31, 2024



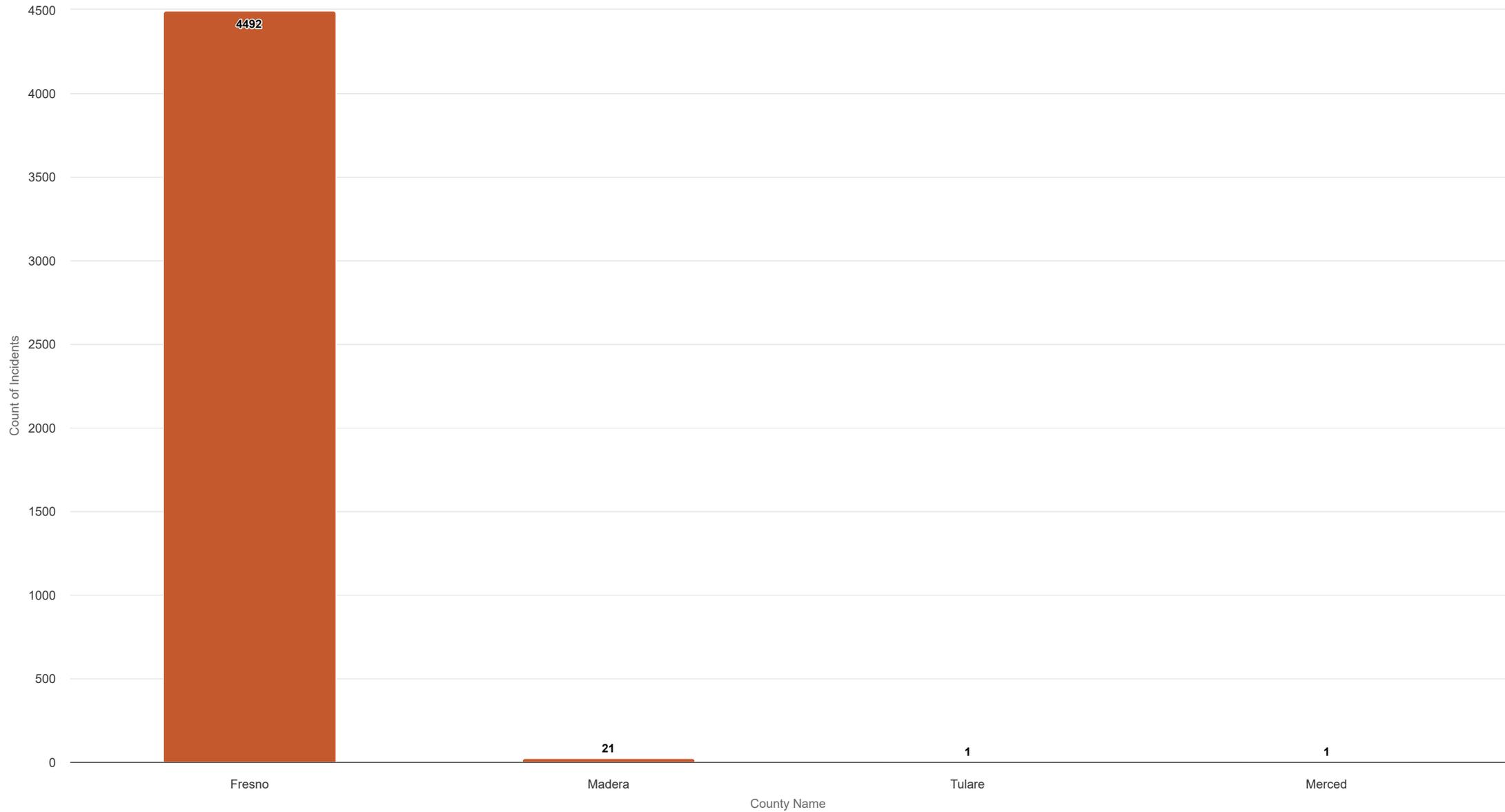
**Incidents by City Name (Top 15)**

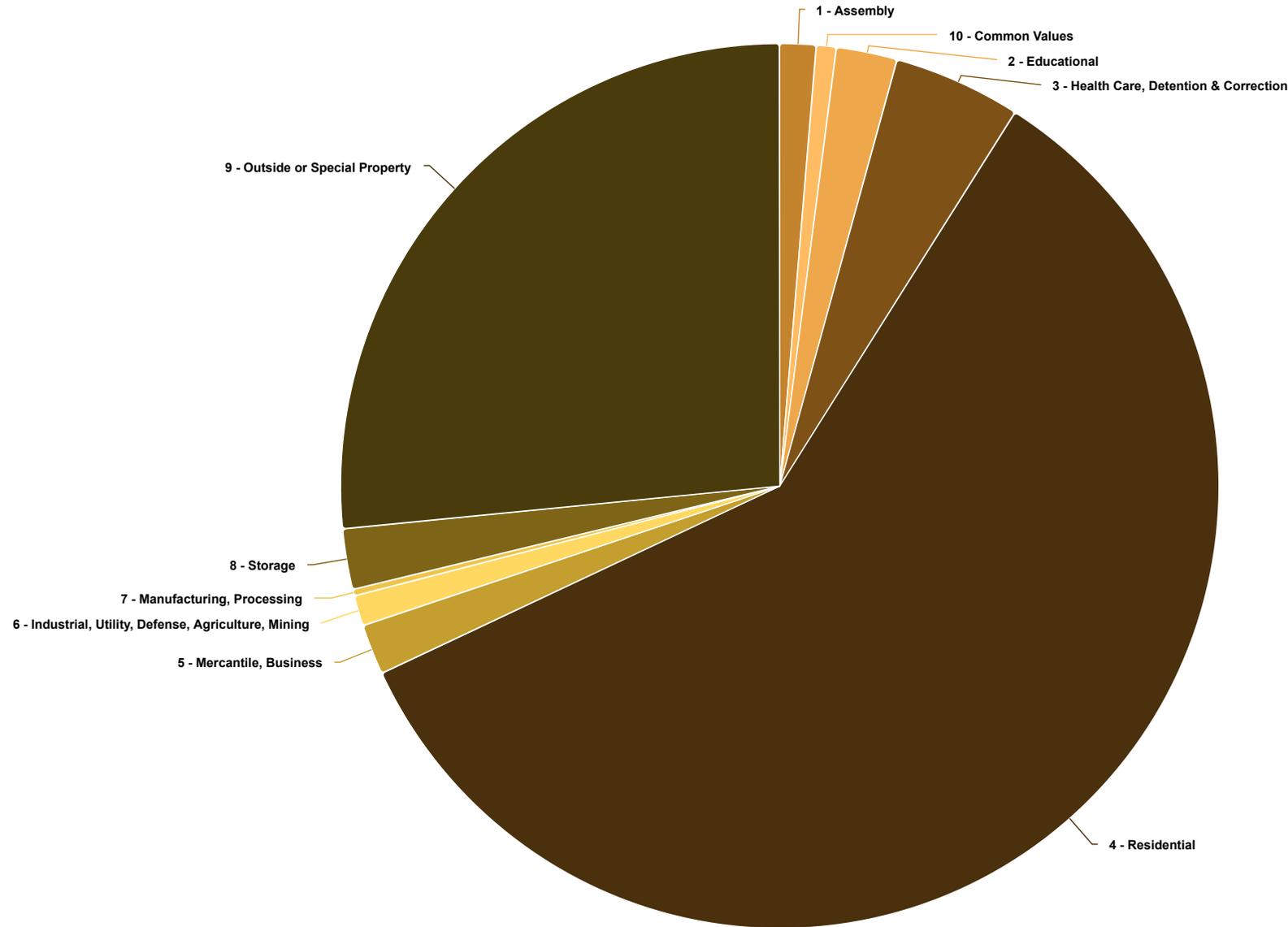
**Incidents by County Name (Top 15)**

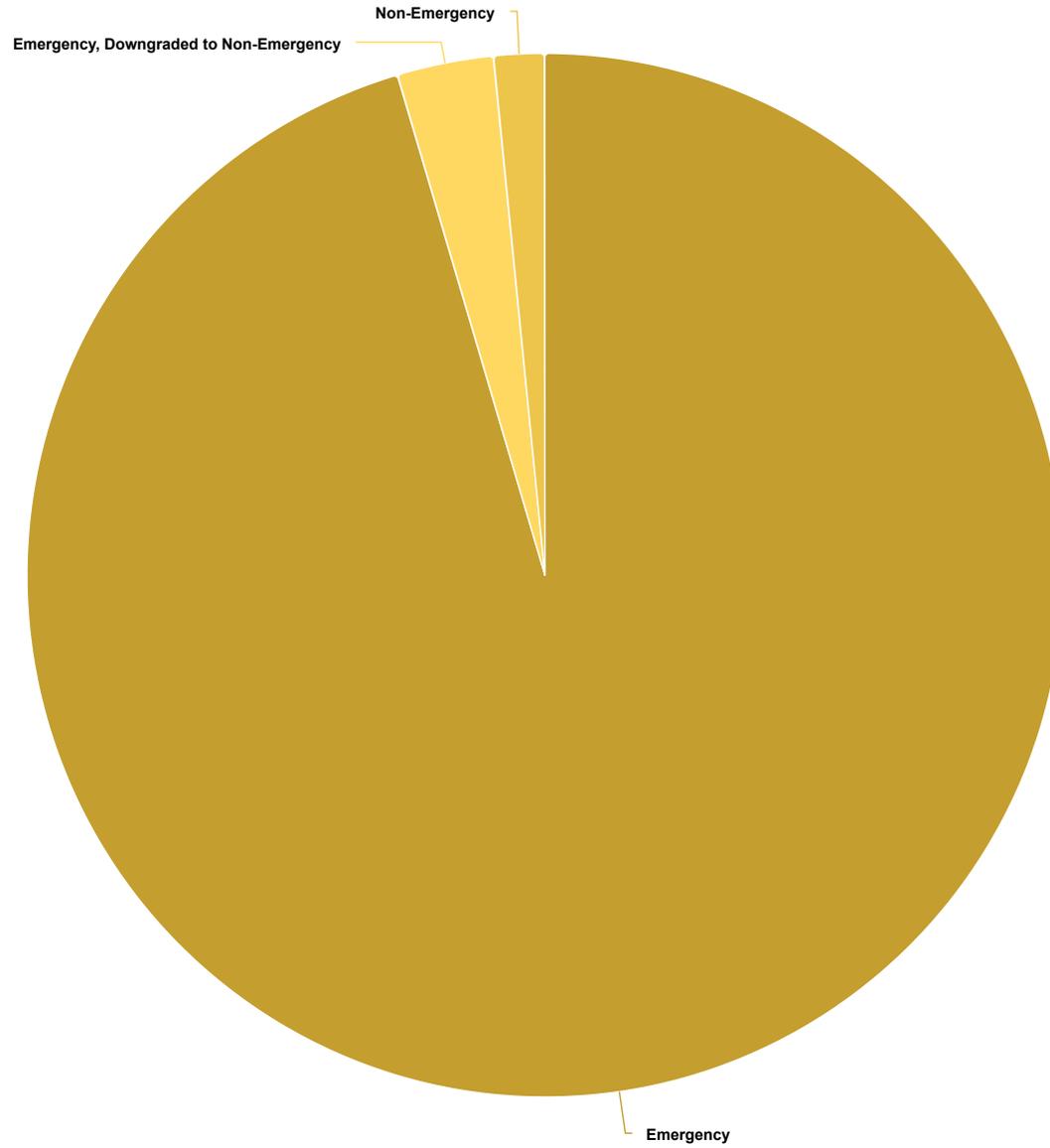
**Incidents by Property Use Category**

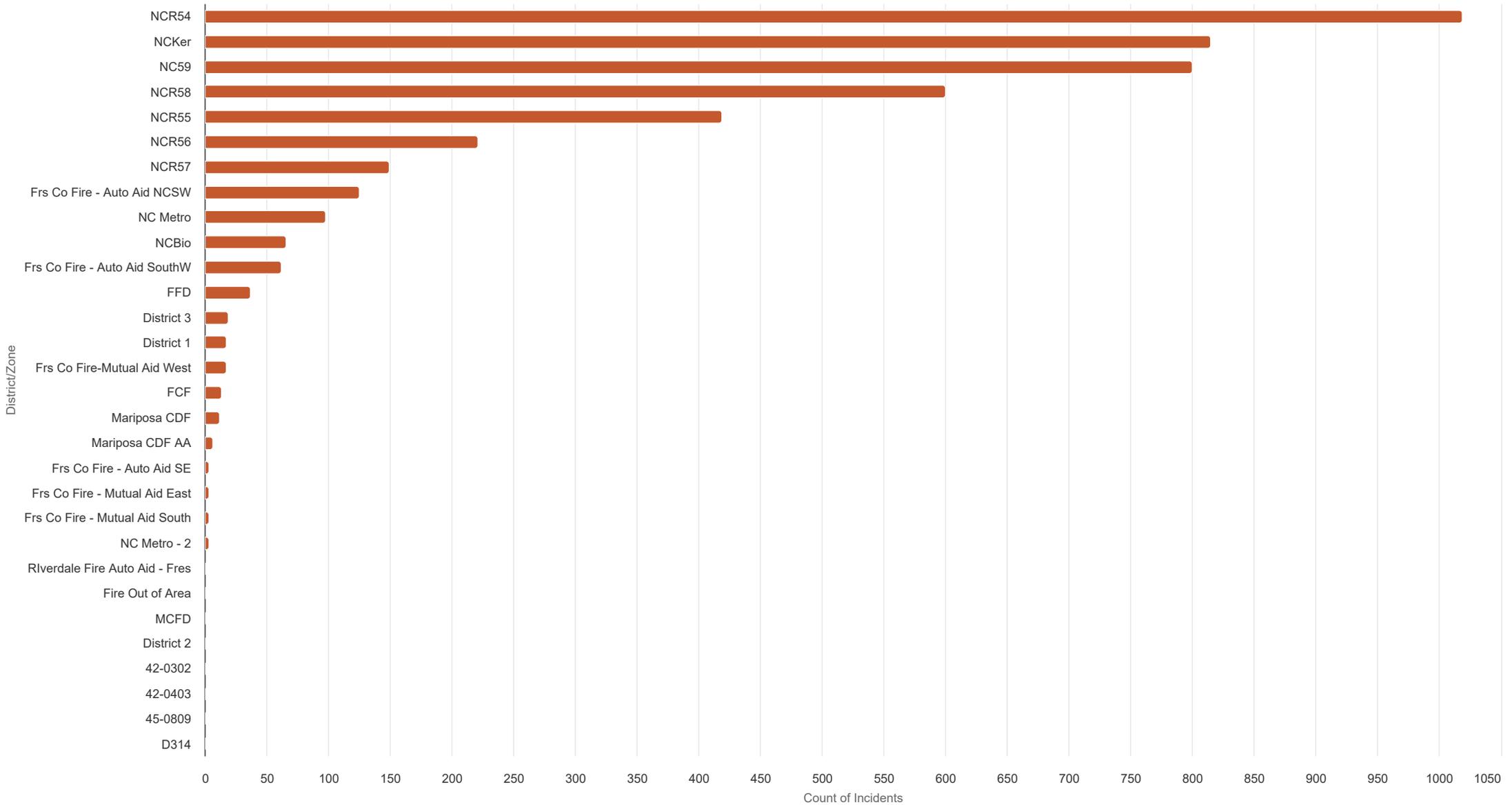
**Incidents by Response Mode To Scene**

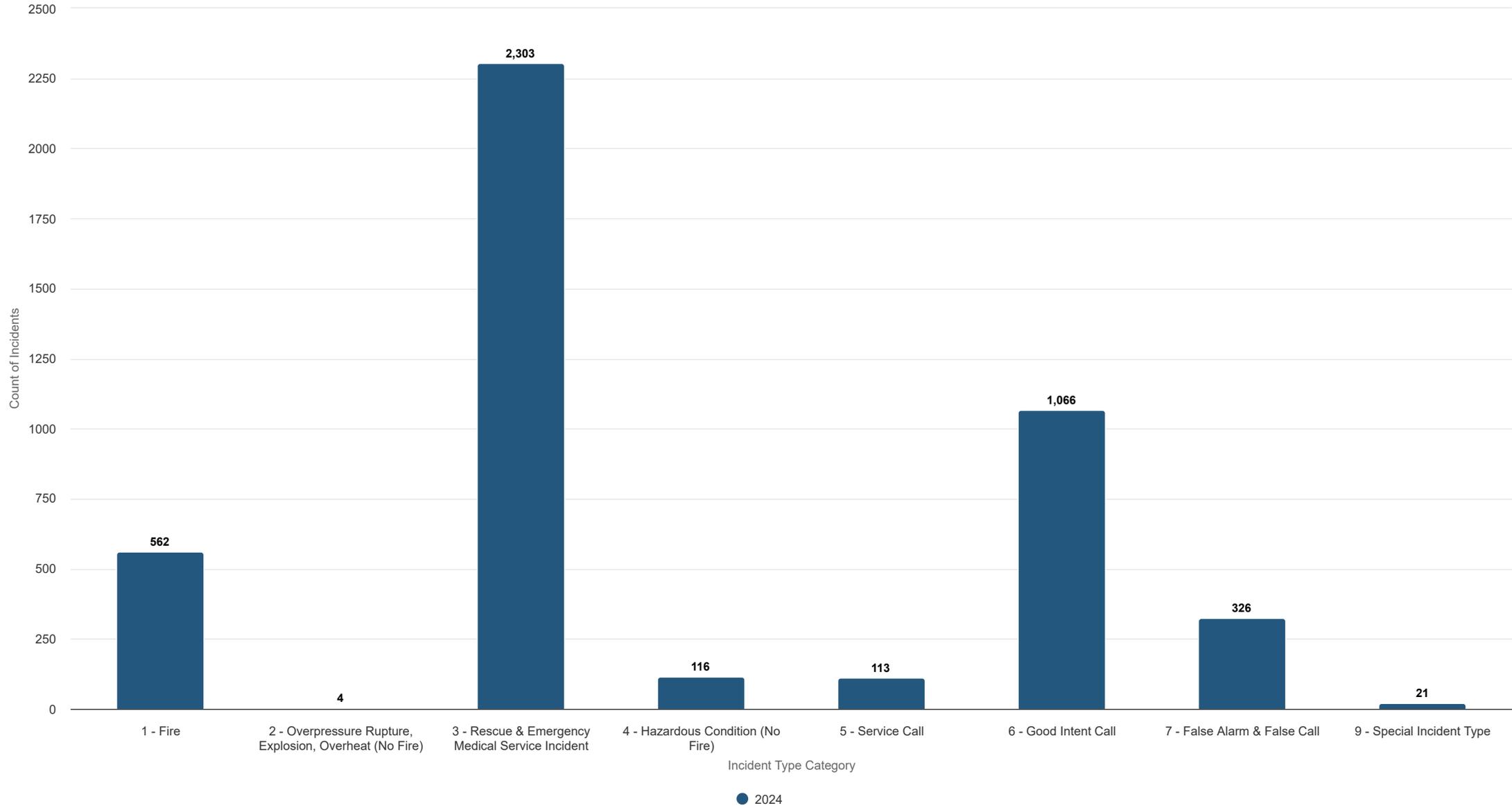

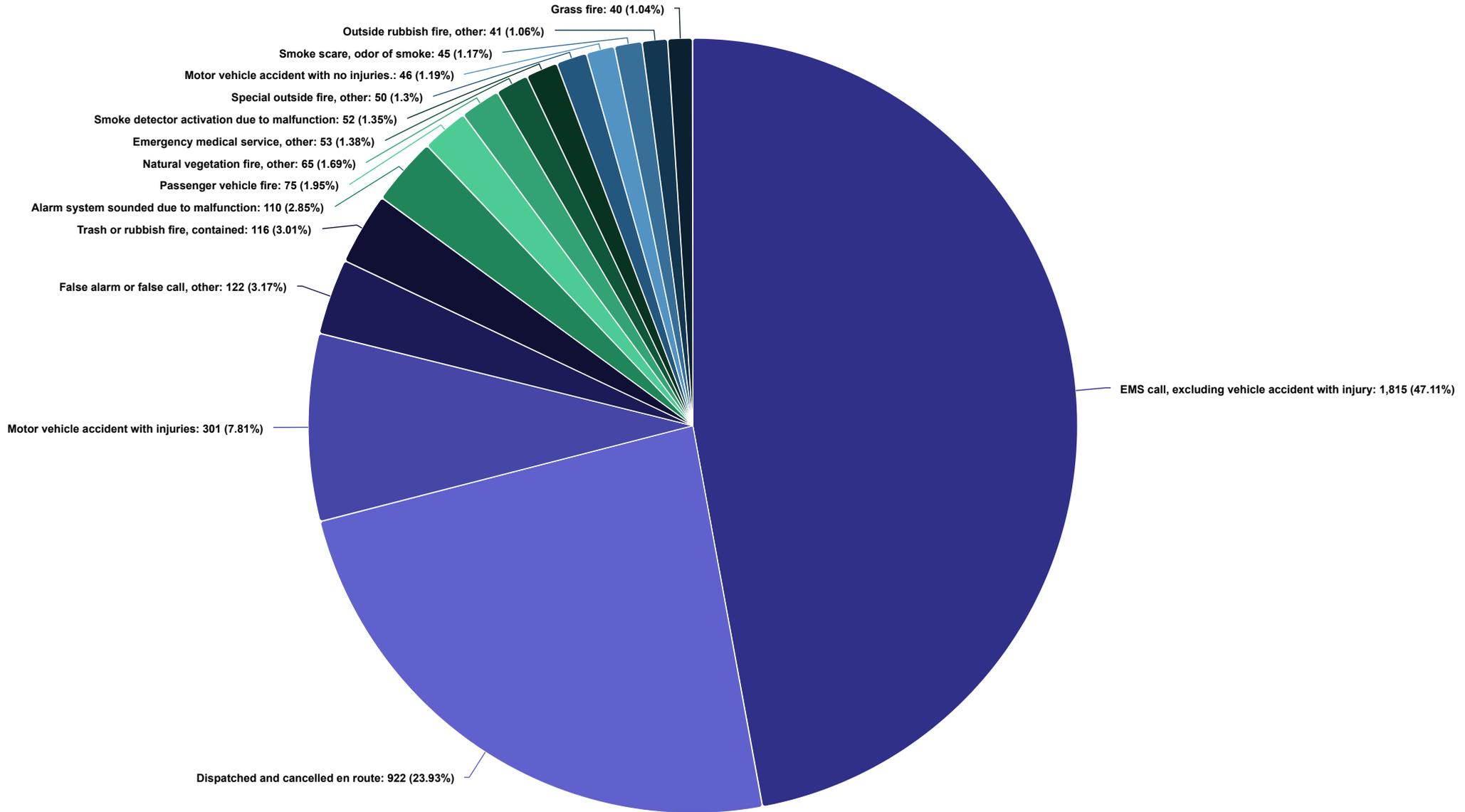
### Incidents by Category and Year

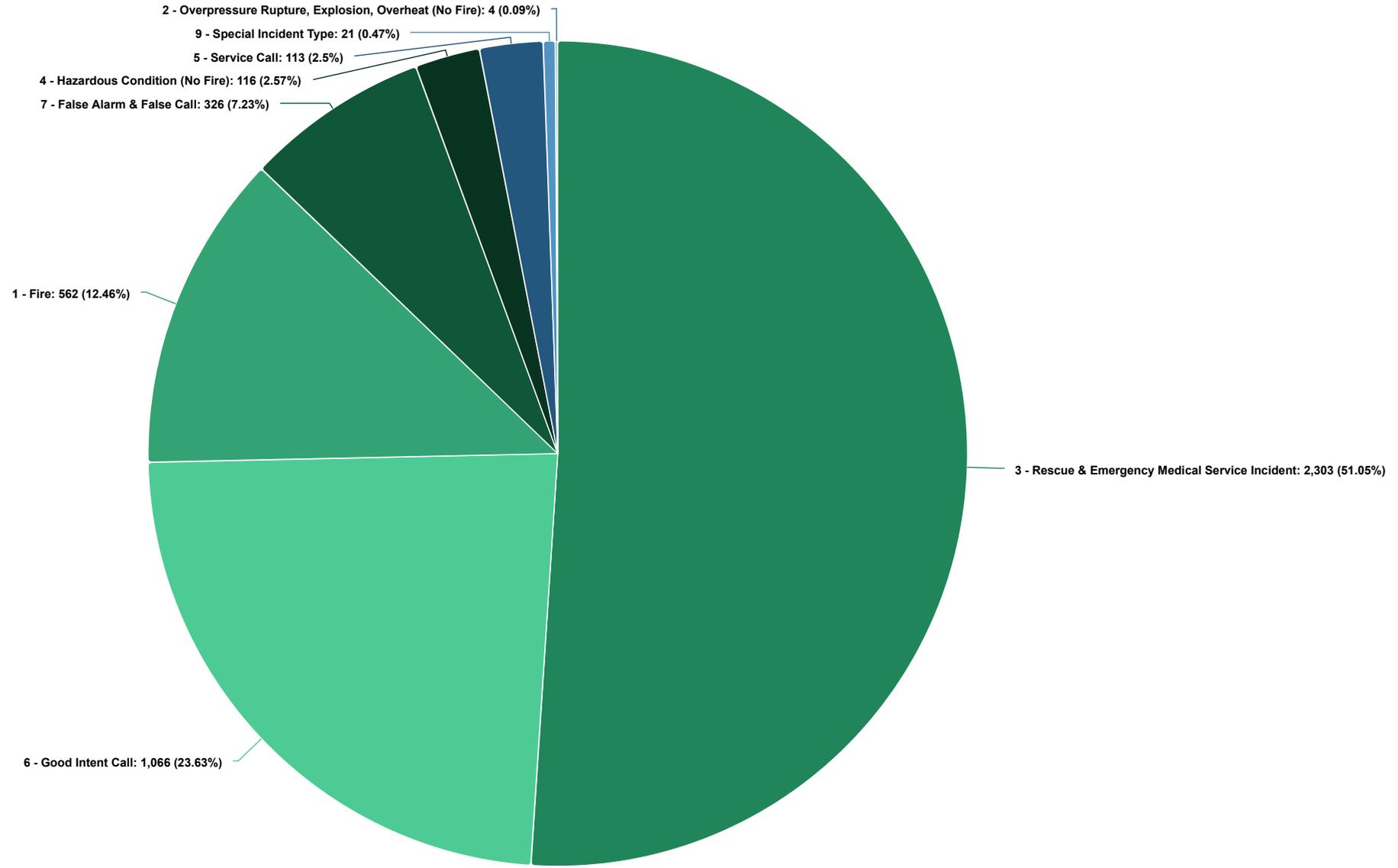
**Incident Types (Top 15)**

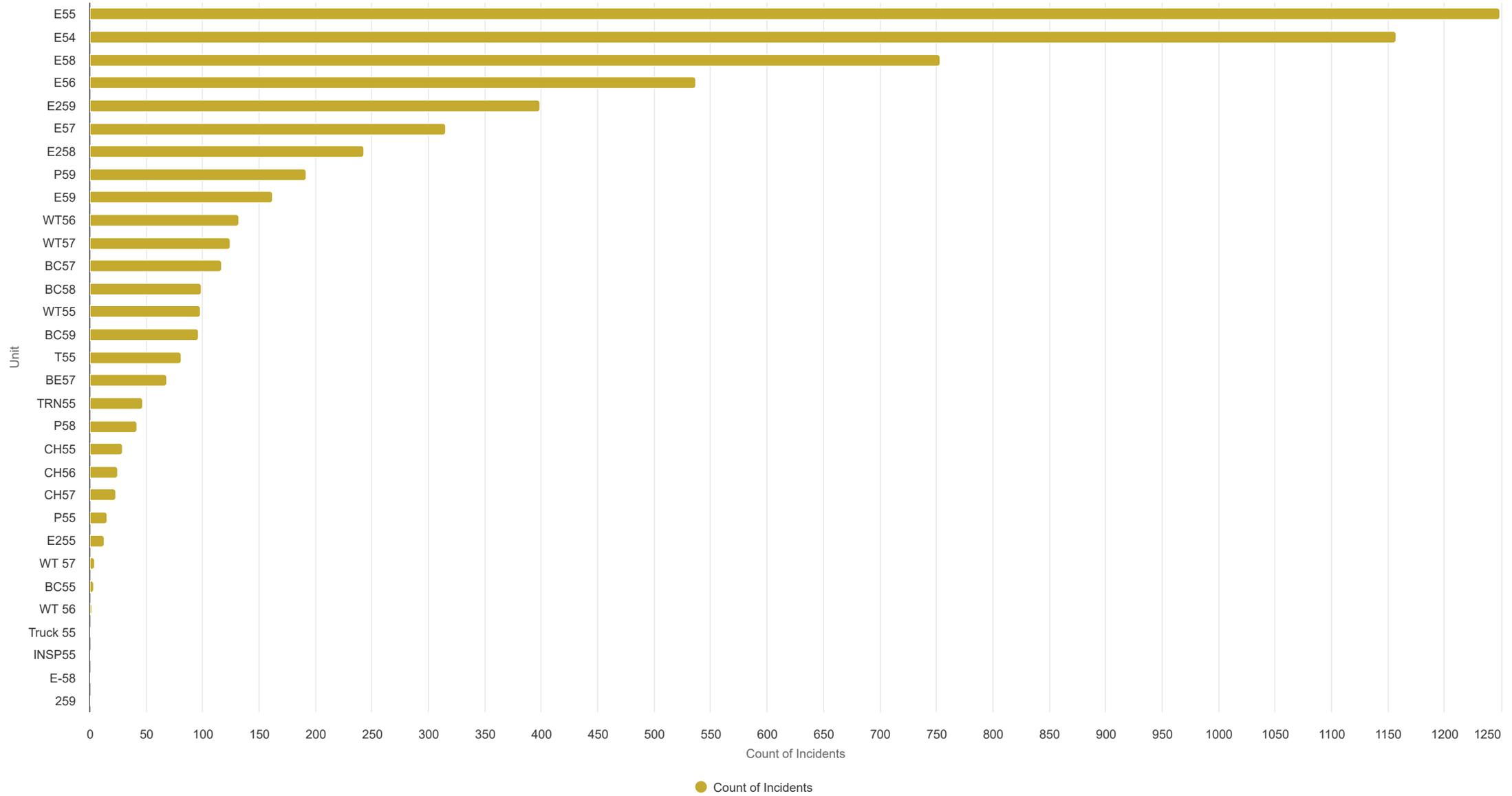

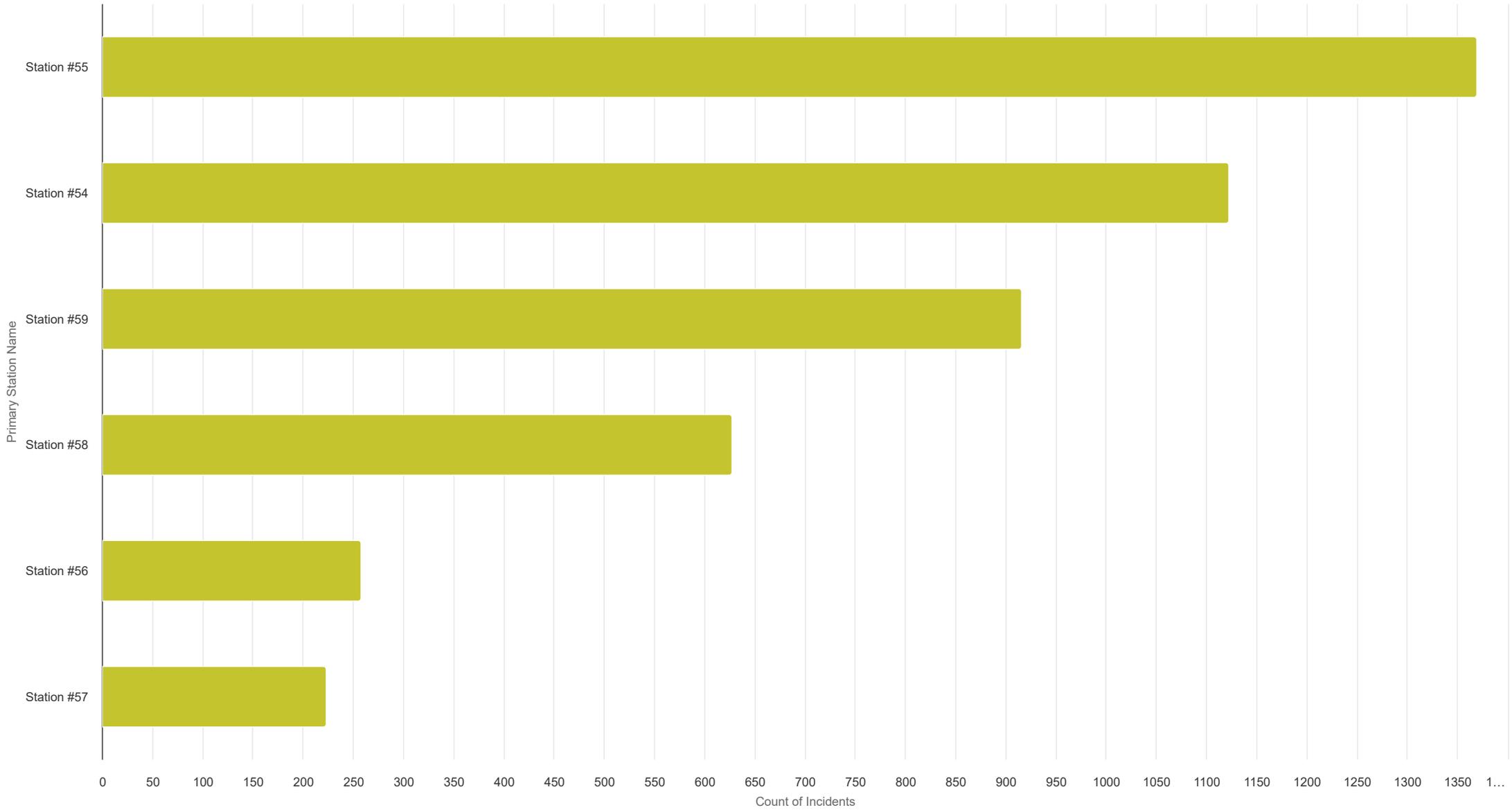
**Incidents by Apparatus Resource ID (Top 40)**

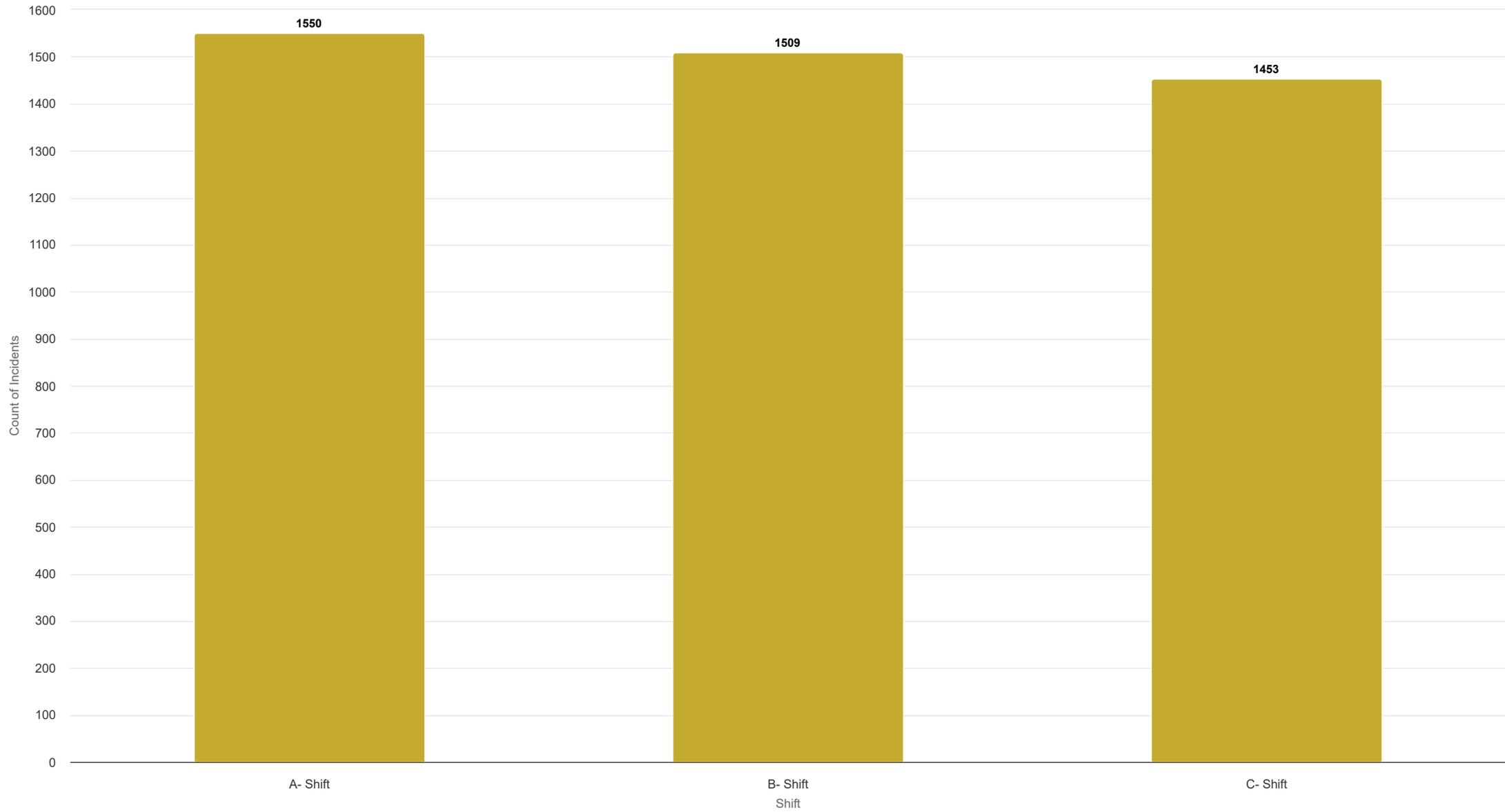

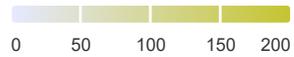

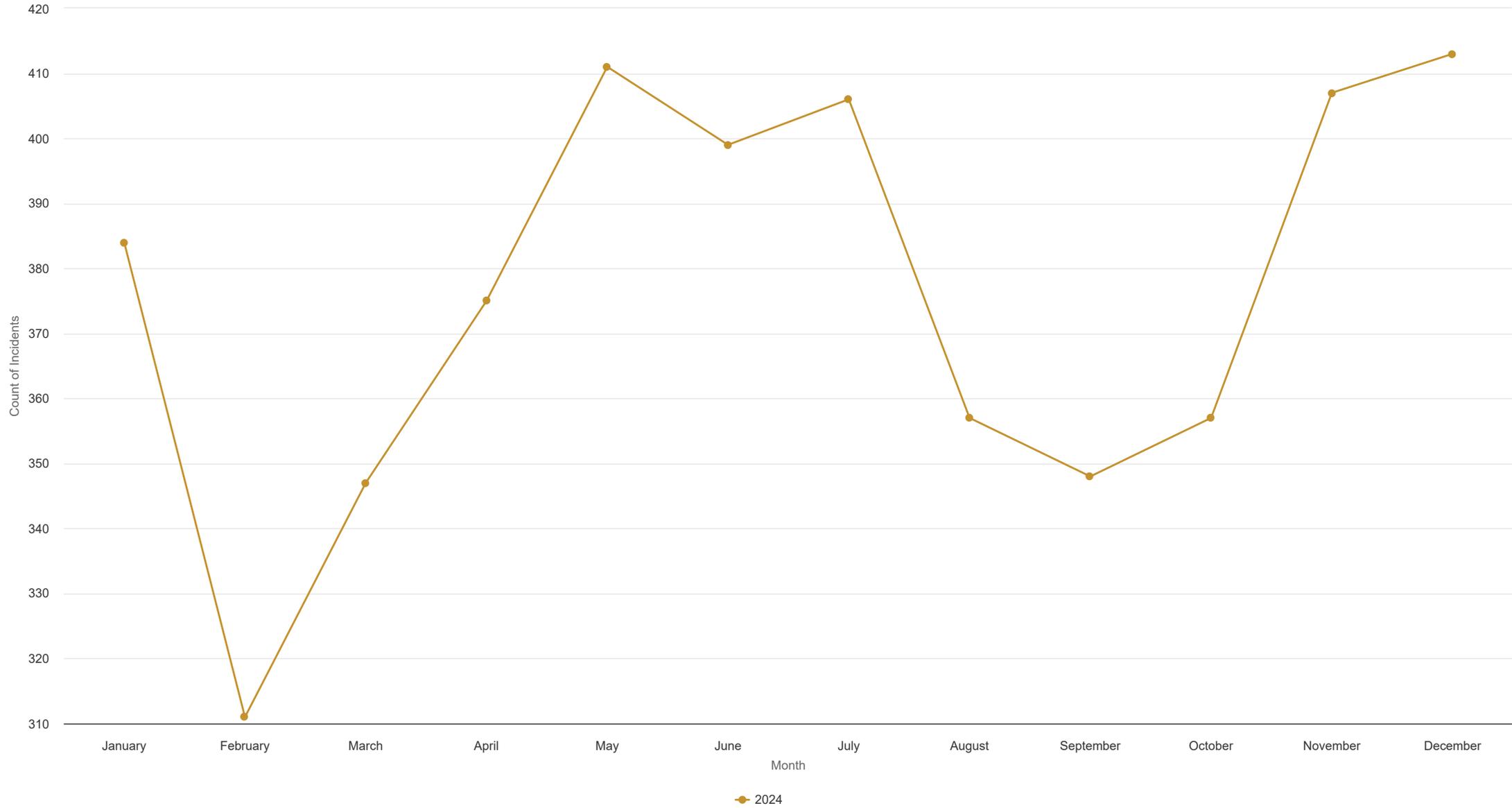

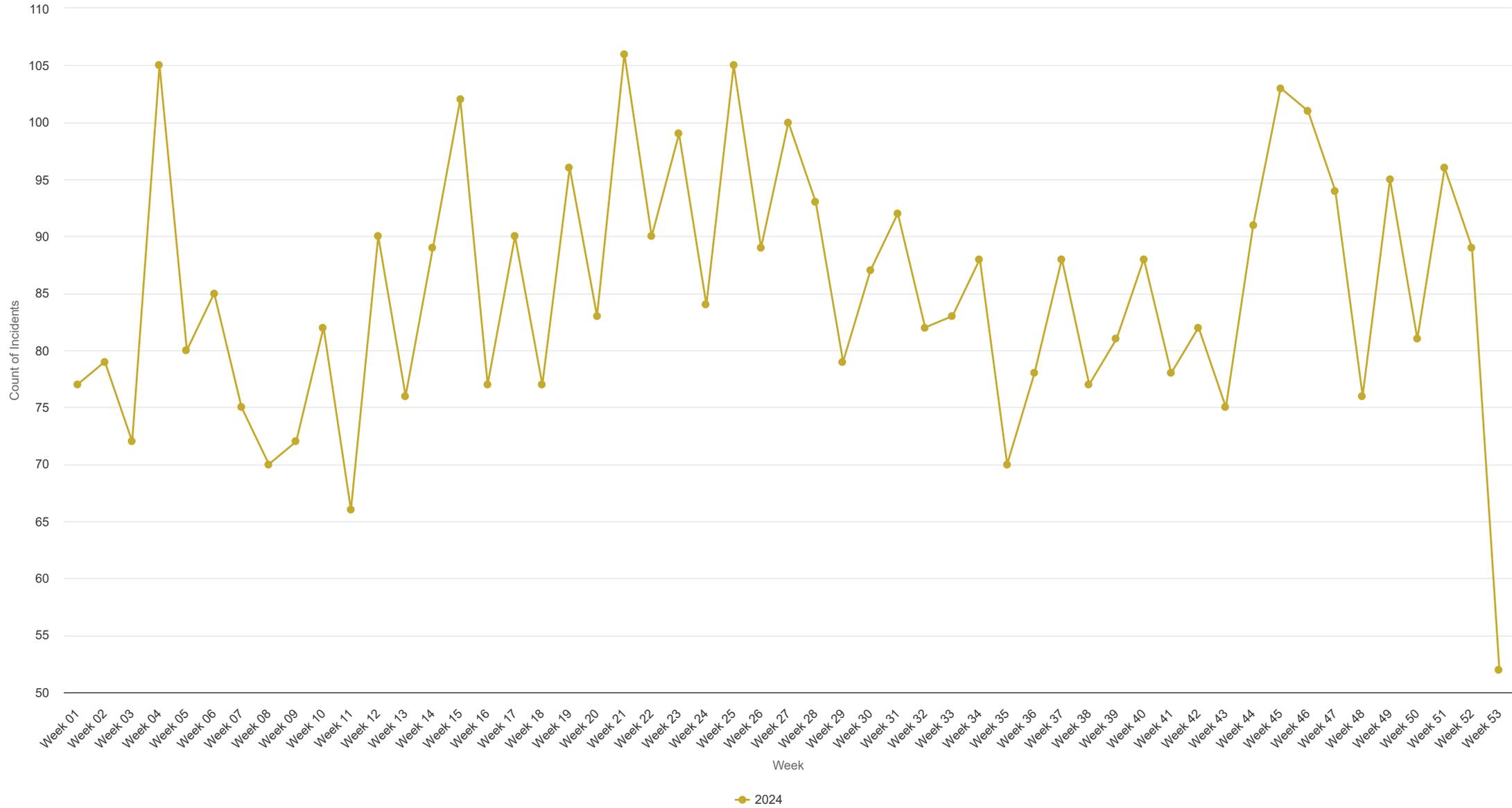
**Fire Call Volume by Month**

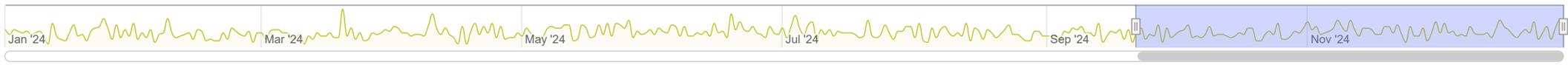
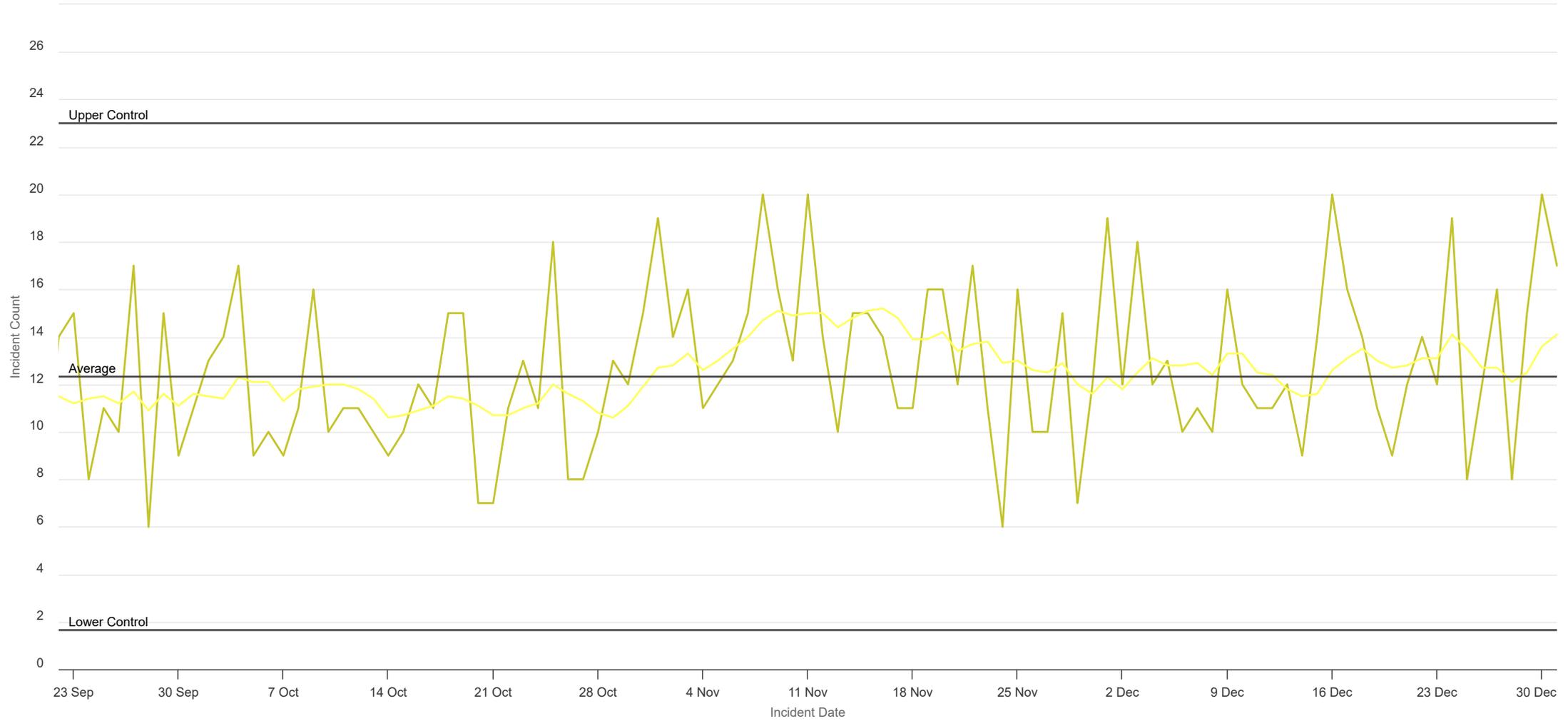


**Fire Call Volume by Week**

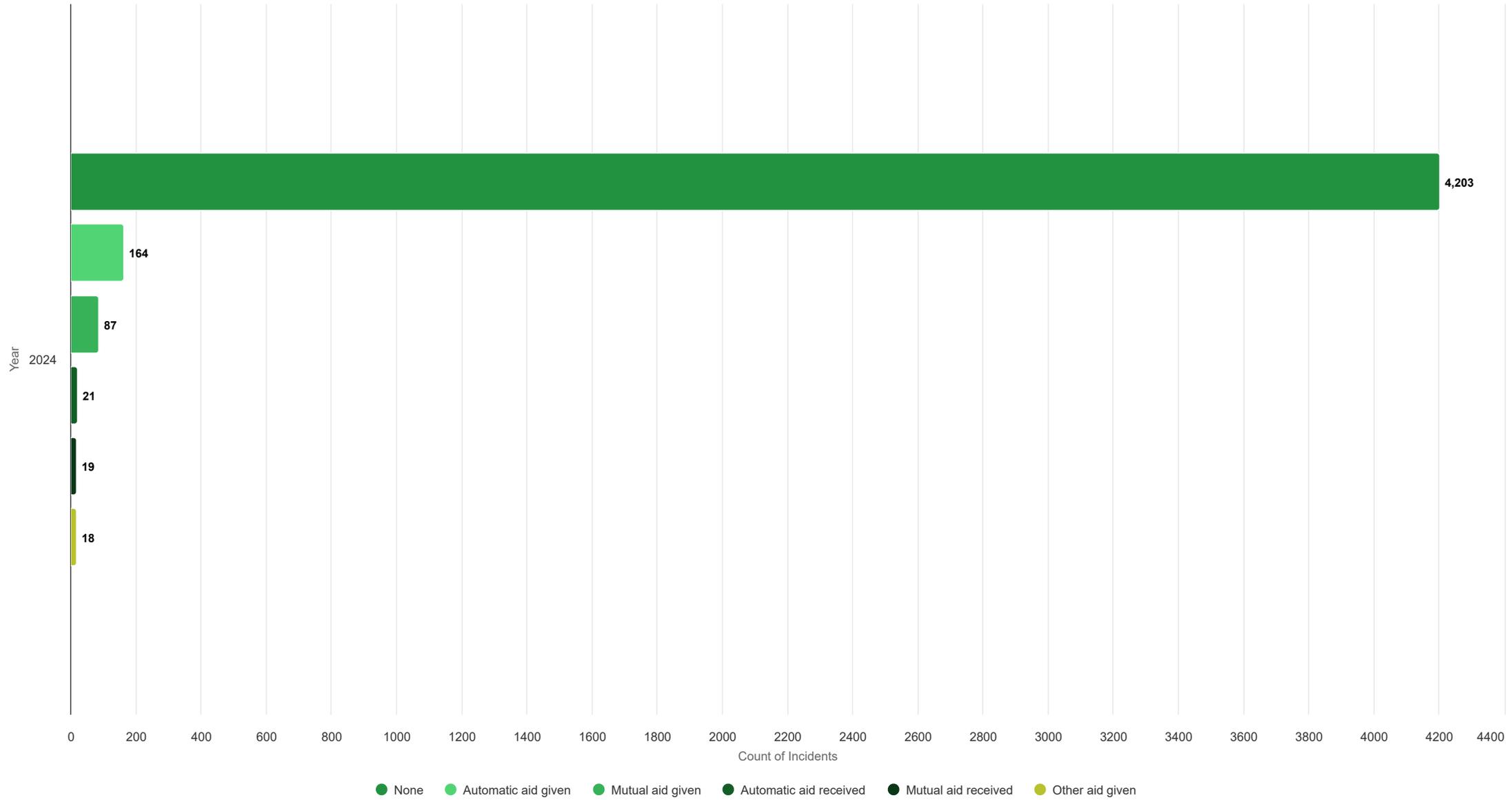

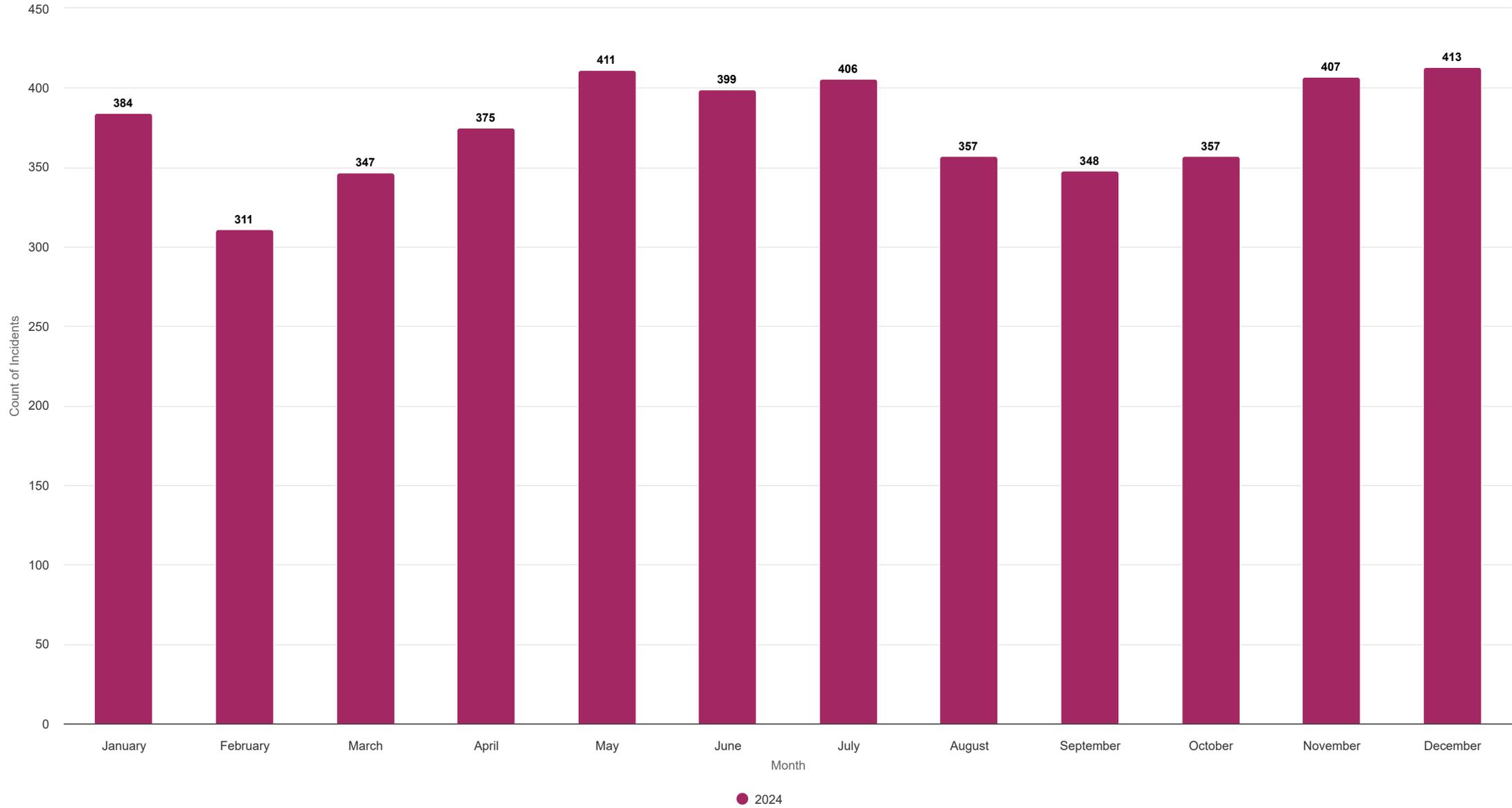

Monthly Call Volume Year over Year

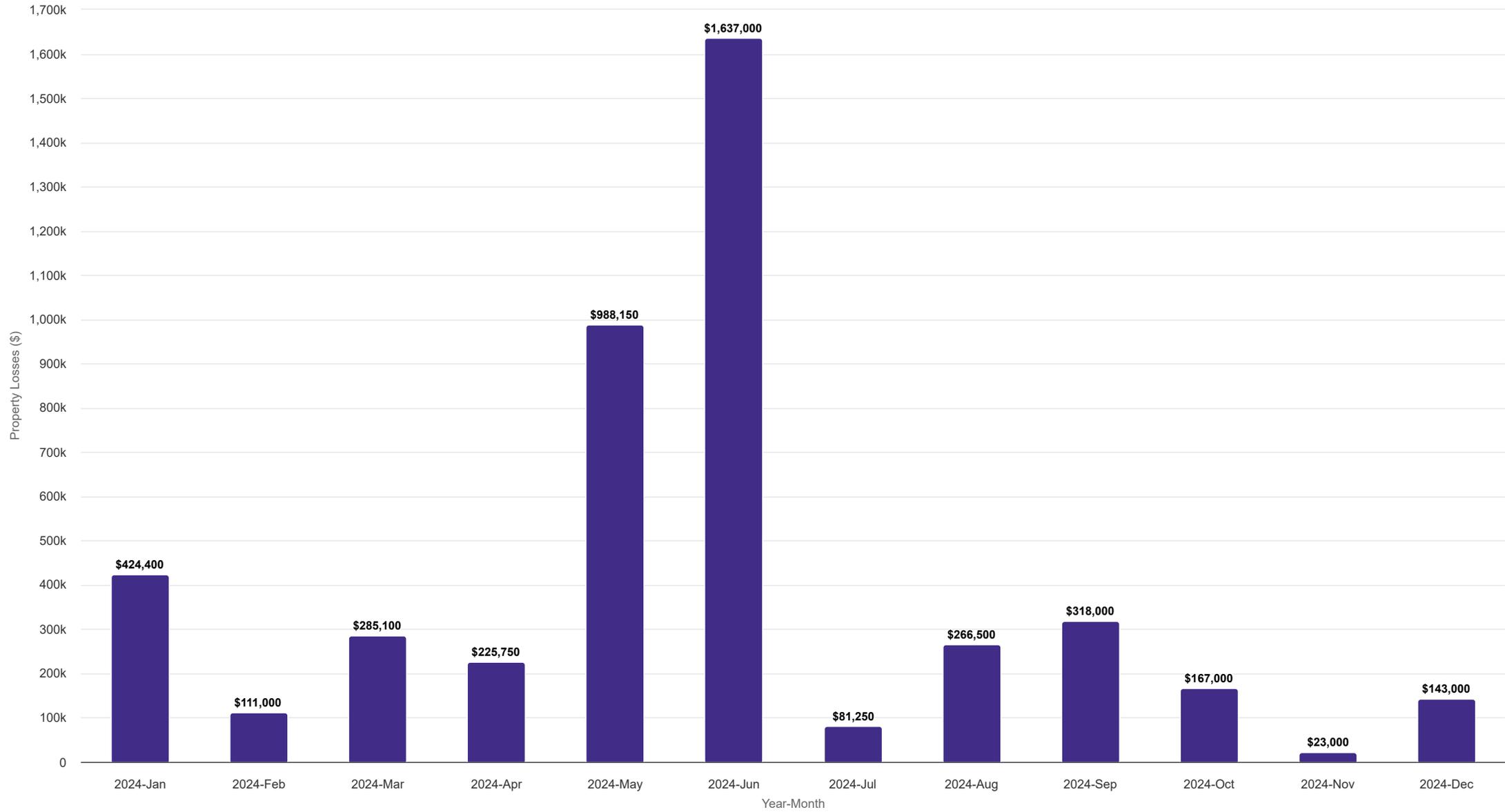

Jan 01, 2024 to Dec 31, 2024



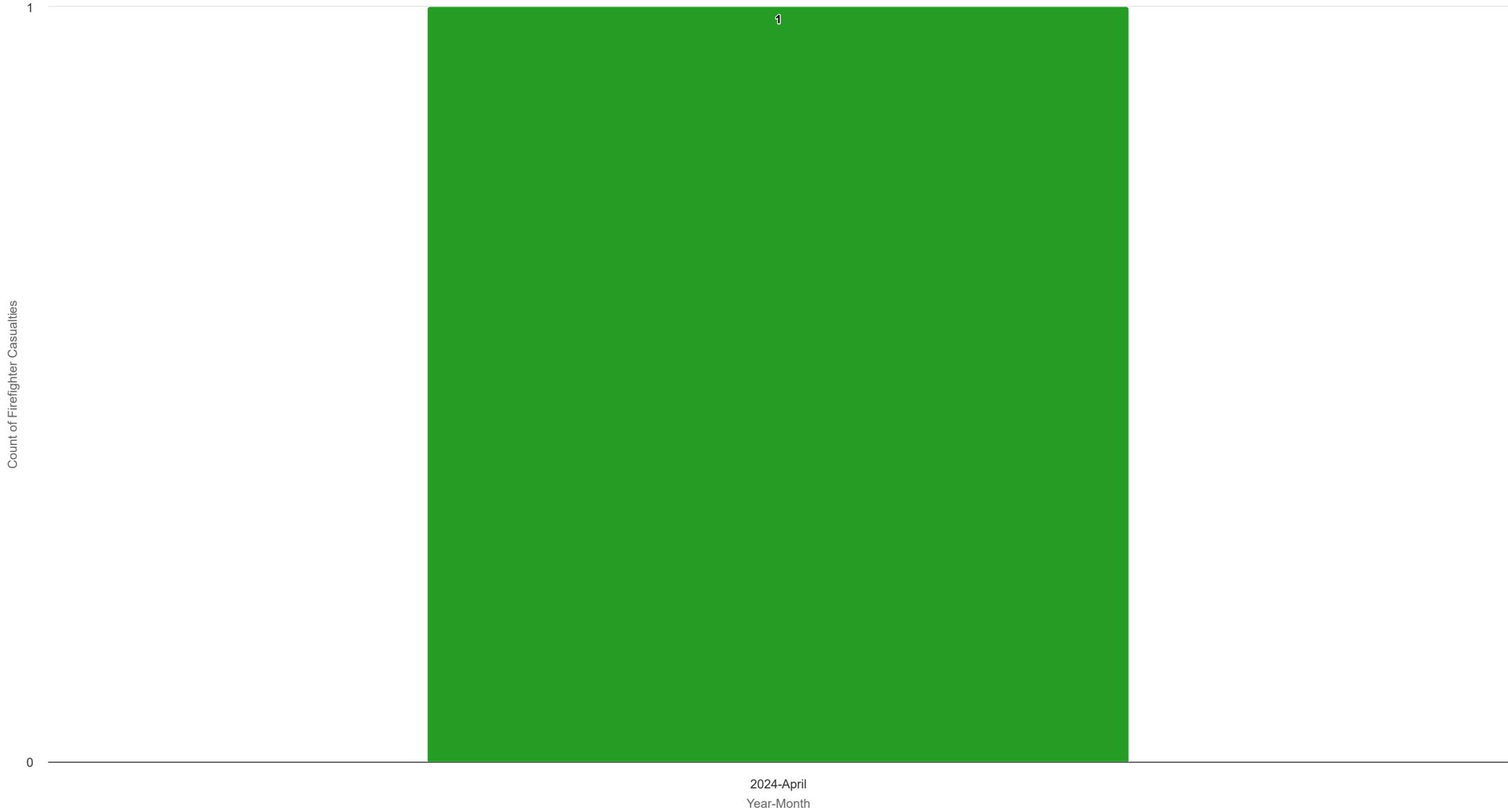

**SUBJECT:** Fire Chief's Report – Reflecting on 2024

Reflecting on the incredible accomplishments of the District in 2024, I am excited to share our organization's growth, progress, and dedication to our mission statement by exceeding traditional fire service expectations as we look ahead to 2025. Here is a glimpse into the review of what commitment to our community means for us:

### OPERATIONS

#### New Apparatus:

Received and placed-in-service (3) new Type I Engines at fire stations 54, 58, & 59.

#### Equipment Upgrades:

Provided 4 gas atmospheric monitors on each engine (6). Implemented a comprehensive and aggressive hose and nozzle package for all apparatus. Smooth bore/2.25 blitz lines and 1.75 initial attack lines. Provided personal TICs for all riding positions (24)

#### Personnel Support

- Established a Peer Support Team and initiated a Fire Chaplain program
- Upgraded all District gyms with new equipment

### TRAINING

- Welcomed 11 new firefighters to our team
- Completed the construction of a multi-story live burn facility

*"Our Mission: To integrate with our community by exceeding traditional service expectations"*

- Successfully completed Teacher Credentialing for two ROP instructors
- Commenced the third year of our Fire Regional Occupational Program with 25 students from Kerman Unified

The District implemented a FEMA Assistance to Firefighter Grant (AFG) totaling \$168,000. The various training programs included an 8-month advanced leadership program and 20+ California State Fire Marshal (CSFM) certified classes for Officers, Instructors, Inspectors, Drivers, Rescue, Hazmat, and Safety Officers.

## **ADMINISTRATIONS**

- Awarded a CBDG grant for a new 2,000 gal. Tactical Water Tender
- Received Board support to move forward on the purchase of a replacement Ladder truck
- Secured an OTS grant of \$50,000 and successfully equipped all six first-out engines with Edraulic extrication equipment
- Added an HR Manager to our team
- Finalized a new Master Fee Schedule for the District
- Collaborated with Fresno City College to host 12 intern firefighters
- Transitioned to a new Records Management System (RMS)

### **District Website:**

In 2024, the Fresno County Grand Jury reviewed the District's website to ensure compliance with California law.

North Central Fire Protection District website is required by State law and is designed to provide accessible information to all members of the public, ensuring that individuals with disabilities can understand and use the site effectively. This commitment aims to provide quality information that is accessible to everyone.

## **LABOR RELATIONS**

Local 5260 Memorandum of Understanding - 2-Year Extension:

### **Term of the Agreement and Parties Involved:**

- The agreement is between the North Central Fire Protection District and the North Central Professional Fire Fighters Local 5260.
- The term of the agreement is extended to December 31, 2026, expiring on January 1, 2027.

### Health and Welfare Increases:

- Effective the first full pay period following ratification and Board adoption:
  - The District's Health Contribution Maximum cap will increase from \$1,600 to \$1,900 per month.
  - Permanent (non-probationary) employees not participating in the District's health, dental, or vision insurance programs are eligible to receive up to a \$300 employer contribution per month to the District's sponsored 457(b) deferred tax account.
  - Probationary employees without permanent status not participating in the District's health, dental, or vision insurance programs will accrue up to a \$300 per month credit towards a 457(b) deferred tax account, to be deposited by the employer upon gaining permanent status. If the employee separates before gaining permanent status, they forfeit any accrued contributions.

### Wage Adjustments:

- Effective the first full pay period following January 1, 2025:
  - Step IV will be added to the Salary Scale with a 5% increase above Step III for Fire Engineers and Fire Captains.
  - Realignment of the wage scale for Firefighter I/II:
- Effective the first full pay period following January 1, 2026:
  - Step V will be added to the Salary Scale with a 5% increase above Step IV for Fire Engineers and Fire Captains.
- Effective the first full pay period following December 31, 2026:
  - The District will realign the wage scale for Fire Captains.
  - A 3% wage increase will be applied to all ranks.

### Unfair Labor Practice Findings:

The document is a letter from the California Public Employment Relations Board (PERB) regarding an unfair practice case, North Central Professional Fire Fighters Local 5260 v. North Central Fire Protection District, dated November 13, 2024. The case involves allegations by the North Central Professional Fire Fighters (NCPFA) that the North Central Fire Protection District unilaterally reassigned bargaining unit work to non-unit firefighters without proper negotiation, violating the Meyers-Milias-Brown Act (MMBA).

The procedural history outlines the filing of the unfair practice charge by NCPFA on September 28, 2022, the issuance of a complaint, and the subsequent hearings held in early 2024. Ultimately, the Administrative Law Judge found that NCPFA failed to prove that the District violated the MMBA or made an unlawful unilateral change to past practices regarding staffing assignments.

The proposed decision resulted in the dismissal of the complaint and the underlying unfair practice charge, indicating that the District had long used limited-term firefighters (LTFs) interchangeably with full-time firefighters (FTFs) and that there was no deviation from established practices. NCPFA was also advised of its right to appeal the decision within 20 days if it wished to contest it.

## **PLANNING**

Property acquisition:

In 2024, the Board initiated the land procurement process to meet the District's future needs.

The District Board Members were committed to the organization's growth, progress, and dedication to exceeding traditional fire service expectations. As we look ahead to 2025, closing escrow on a new property in the first quarter of the year and beginning the planning phase of developing a new fire station, training center, and emergency operations center is a significant step toward disaster preparedness and population growth. Having these facilities in place will undoubtedly enhance the capabilities and preparedness for responding to emergencies and disasters within the North Central Fire Protection District, including the City of Kerman.

I am elated to see the commitment to improving resources and infrastructure to serve the community better. If there are any specific details or updates on the progress of this development, I will ensure the Board is aware of them.
