WEED ABATEMENT RESOLUTION AUTHORIZING THE ASSESSMENT OF PUBLIC
NUISANCES THAT CONSTITUTE A FIRE HAZARD AND ASSESSING THE COST OF
REMOVAL TO THE FRESNO COUNTY TAX ROLLS

At a regular meeting of the Board of Directors of North Central Fire Protection District, it was moved by director Belluomini, and seconded by director Foglio, and duly carried that the following resolution be adopted:

WHEREAS, The North Central Fire Protection District Board of Directors duly called and held a public hearing on April 25, 2019, which established that a public nuisance exists on certain described properties in the fire district, and,

BE IT THEREFORE RESOLVED, that the property described in attached Exhibit A has been abated of grass, weeds, stubble, brush, litter or other material that constitutes a fire hazard, and,

FURTHERMORE, the North Central Fire Protection district shall assess the cost for the abatement of the above described properties to the Fresno County Tax Rolls.
