That the District's Operating Expenditures for Apparatus Maintenance, Professional Services, Computer Maintenance and Support and Fire Prevention be increased. And to increase Start-up Expenses for pre-placement physicals and Capital Improvement Expenditures. All of these increases are related to the District standing up the department. The Operating Expenses listed on the table below are start-up expenses included in the operating expenses in the 2018-2019 adopted final budget. The Capital Improvement Expenditures were approved by the District Board after the final budget was adopted so they need to be added to the final budget via this resolution amending the final budget.
